Subject: Guidelines for implementation of Amendment No. 1, September 2018 to IS 7021: 2017 for Protein-Rich Food Supplements for Infants and Pre-School Children-Specification (First Revision)

- 1. Amendment No. 1, September 2018 to IS 7021:2017 "Protein-Rich Food Supplements for Infants and Pre-School Children" (First Revision) and has been published and notified vide Gazette Notification S.O.4882 (E) dated 17 September 2018. The date till which the Standard without Amendment No. 1, September 2018 to IS 7021:2017shall remain in force was 11 October 2018.
- 2. All BOs may inform the Licensees/Applicants under their jurisdiction about Amendment No. 1, September 2018 to IS 7021:2017.
- 3. The significant changes in Amendment No. 1, September 2018 to IS 7021:2017, as listed in the Table below, are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

- 4. Consequent upon issuance of Amendment No. 1, September 2018 to IS 7021:2017, existing STI is being revised as **Doc: SIT/7021/1 October 2018**.
- 5. Implementation of the Amendment No. 1 is to be done with immediate effect.
- 6. The guidelines for implementation of the Amendment No. 1, September 2018 to IS 7021:2017 are as follows:

A. For licensees:

- i) All Licensees shall switchover to Amendment No. 1, September 2018 to IS 7021:2017 with immediate effect. ROs/BOs shall ensure that no Licence is under operation as per the old Standard.
- ii) Actions shall be taken as per BIS (Conformity) Assessment Regulations, 2018 on the subject, if the licensee fails to comply with guidelines given at 6 A (i) above.

B. <u>For Applicants</u>:

i) Existing applications and applications which are recorded henceforth shall be processed only as per Amendment No. 1, September 2018 to IS 7021:2017.
