Subject: Guidelines for implementation of Amendment No. 03 to IS 15658: 2006 'Precast Concrete Blocks for Paving'.

- 1. Amendment No. 03 to IS 15658 : 2006 has been published. The last date for implementation of the amendment is 28 February 2019.
- 2. All BOs shall inform the Applicants/Licensees under their jurisdiction about implementation of the above amendment.
- 3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

- 4. Consequent upon issuance of the amendment, existing STI has been revised as SIT Doc: SIT/IS 15658/1, June 2018
- 5. The guidelines for implementation of the amendment is given below:

#### A. For Licensees:

- (i) All Licensees shall implement the amendment by 28 February 2019. BOs shall ensure that no Licences are under operation as per IS 15658: 2006 without the amendment after 28 February 2019.
- (ii) Licensees shall confirm conformance to the additional requirements through In-house/ Independent Test Reports or Test Certificates, as applicable. Verification of additional requirements and facilities, if any, may be done during the next visit.
- (iii) BO may issue endorsement for the revised SIT after receipt of SIT Acceptance and the confirmation from the Licensee on implementation of the amendment. If the Licensee fails to complete all actions by 28 February 2019 it shall be dealt with as per OMPC.

## **B. For Applicants:**

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration from the Applicant may be obtained to that effect and the Application may be processed accordingly. An undertaking from such Applicants shall also be obtained that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications, which are recorded henceforth, may be processed with or without consideration of the amendment. Processing of Applications without consideration of the amendment shall be permitted only upto 28 February 2019 and for such cases Applicant shall give a declaration that they will implement the amendment by 28 February 2019.
- (iii) Beyond 28 February 2019 no Licence shall be granted without consideration of the amendment.

#### C. For Inclusions:

- (i) For Inclusion of New Varieties, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of Inclusions without consideration of the amendment shall be permitted only upto the date of implementation of the amendment by the licensee or upto 28 February 2019 whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
