# Subject: Guidelines for implementation of Revised IS 8088: 2019, Tricycle, Hand Propelled

- 1. IS 8088: 1976 has been revised as IS 8088: 2019 and has been published. The last date for implementation of the revised Standard is 17 12 2019 after which the old Standard shall stand withdrawn.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. The significant changes in the revised Standard as listed below is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.
  - a) Provision of 'Bicycle rim tapes and buckles' as per IS960 : 2005 in place of 'cotton webbing, proofed and unproofed' according to IS 7298 : 1973;
  - b) Provision of 'expanded vinyl coated fabrics' as per IS 8698 : 1984 in place of 'vinyl coated fabrics' as per IS 1259 : 1984;
  - c) Tolerance on the following dimensions have been modified:
    - 1) Overall length from 10 mm to 50 mm;
    - 2) Overall width from 10 mm to 25 mm; and
    - 3) Overall height from 10 mm to 25 mm.
  - d) Clearance of foot rest from ground has been modified from  $120 \pm 10$  mm to  $145 \pm 25$  mm:
  - e) Fig. 1 has also been modified to make use of other shapes of Structural steel tube in addition to round shape;
  - f) Minimum thickness of seat and back rest have been modified as 8 mm
  - g) Diameter of wire used to made steel stay of mudguard has been modified as 4 mm minimum in place of 4.8 mm and minimum clearance between the wheel and fork has been modified as 8 mm in place of 10 mm;
  - h) Designation of drive chain has been modified as 081 in place of 083;
  - i) Dimension of tubes used for frame have not been specified, Sizes used shall satisfy tests specified in the standard;
  - j) All the Indian Standards cross-referred have been updated.
- 4. Consequent upon the issuance of the revised Standard, existing STI has been revised as Doc: SIT/ IS 8088/ 1/ April 2019
- 5. The guidelines for implementation of the revised Standard is given below:

#### A. <u>LICENSEES</u>:

- (i) All Licensees shall implement the revised Standard by 17 12 2019. BOs shall ensure that no Licences are under operation as per the old Standard after 17 12 2019. The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.
- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports or Test Certificates, as applicable. Verification of implementation of the revised Standard, wherever required, may be done during the next visit which may normally be completed within three months of the last date of concurrent running.
- (iii) If the Licensee fails to complete all actions by 17 12 2019 it shall be dealt with as per the prevailing guidelines.

#### B. <u>APPLICATIONS FOR GRANT OF LICENCE</u>:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall from such Applicants also be obtained that in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto 17 12 2019 and for such cases Applicant shall give a declaration that they will implement the revised Standard by 17 12 2019.
- (iii) Beyond 17 12 2019 no Licence shall be granted as per the old Standard.

#### C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto 17 12 2019 whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
