Thanks for providing IS specifications for Saris.

I would like to make following points with reference to IS 15851:2009

Sari fabric is mostly used in printed form especially when used as uniform. In IS 15851 the fibre composition has been shown as Polyester cotton blend of 67:33 ratio.

As a textile technician I would like to draw your attention to the fact that printing of PC blend fabric involves many difficulties like sharpness of print, time and material consumed and the cost involved.

Also it is not a very common fabric for saris.

Most of the sari fabric will have only one component of fibre like 100% cotton, 100% polyester, 100% nylon, 100% silk etc.

The blended saris will also have the components which have a common family of dyes.

Whereas PC blend has two different categories of dyes and printing involves two stages. Both stages also involve altogether different routes.

There may be an alternate route of using pigment printing but at the cost of losing fastness properties.

Requesting you to take up the point relevant committees.
