Respected Sir,

Greetings for the day....!!!

Some importers are engaging in the practice of bypassing QCO of the government of India with regards to textile products, as you are aware the government of India has covered polyester FDY yarn under BIS no import from any supplier who is not registered in BIS is allowed in our country.

However, our members have come across certain mysterious importers who have been ingenious to bypass QCO and import polyester FDY yarn from suppliers who are not registered under BIS. Following parties have resorted to **misdeclaration** for importing polyester FDY yarn as per our knowledge the conform cargo in transit which actually contains polyester FDY yarn (HSN Code 54024700) however in the import declaration it is mentioned as Polyester Drawn Textured Yarn (DTY) (HSN Code 54023300, under Polyester Drawn Textured Yarn 200D/10F & 300D/10F) thus it is clear that the said importer is bypassing the QCO by mis-declaring the goods under import from CHINA.

The BIS department can verify the details below to get authentication of original material description.

- ➤ Included in the shipment are the necessary China Government Export Documents, which are essential for the export clearance from the Chinese authorities. These documents cover the full details of the products being exported, including <u>origin certificates</u>, <u>Customs documents of China, China export shipping bill, bill of lading from original port, documents submitted from exporter to Chinese Govt. & shipping company.</u>
- ➤ We would like to draw your attention to the fact that the Chinese manufacturing company does not have a Polyester Drawn Textured Yarn (<u>DTY</u>) texturizer machines, does not have its production unit, and <u>has never exported</u> Polyester Drawn Textured Yarn (<u>DTY</u>).
- ➤ Please note that the company in Singapore may be altering or falsifying transshipment documents, which are required for the customs clearance process in India. The manipulation of these documents appears to be a deliberate attempt to mislead Indian customs authorities about the true nature of the goods being imported, their origin, or their declared value.
- ➤ We would also like to inform you about the laboratory testing process required by the Customs department for all imported goods under shipment. Because the laboratories are managed by importers for testing purposes. Considering this, we kindly request that you facilitate the testing of all imported goods at the BIS laboratory, in accordance with the necessary procedures and regulations. This process should be a key part of the customs clearance procedure and must be completed before the shipment can be fully cleared for distribution.
- ➤ We also bring to your attention that 200D/10F & 300D/10F Polyester Drawn Textured Yarn (DTY) is not typically used in any fabrics within India. Based on our research and industry knowledge, this specific material is not commonly found in Indian fabric production. Given this, we are seeking clarification on where 200D/10F & 300D/10F Polyester Drawn Textured Yarn (DTY) is being used and in which types of products or applications it is typically involved.

To ensure a better understanding and facilitate further processing, we kindly request that you take samples of fabrics or yarns where 200D/10F & 300D/10F Polyester Drawn Textured Yarn (DTY) is used and send it for the testing at BIS Laboratory. This will help us identify its applications, assess its properties, and understand its suitability for any potential uses in the Indian market or for our specific requirements.

➤ After BIS is applied, low quality goods should not be imported from China at cheap rates. But due to wrong practices of many importers, such goods are imported and sold in the local market. So, that fabric manufacturers (weavers) who buy Chinese goods at cheap rates and sell fabrics and earn a couple of money, while those who manufactures fabrics by buying yarn from the local market are unable to compare the fabric pricing, so that the manufacturers are forced to close the factory, and the employment of small workers is at risk.

If this investigation is done thoroughly, then the foreign funds of our country (India) can be saved, action can be taken against the wrongdoers, and small manufacturers and weavers who make fabrics can earn well by running their factories regularly.

We formally request that samples of all goods imported **Polyester or Nylon Yarns** under the specifications **200D/10F** & **300D/10F** be taken from all the Indian ports and ICDs involved in the shipment process. These samples should be

sent to the Bureau of Indian Standards (BIS) laboratory for thorough testing and quality verification.

Given the importance of maintaining product quality and compliance with local regulations, it is essential that these goods undergo testing at the BIS laboratory to ensure they meet the required standards and specifications. The results of these tests will help confirm the authenticity, safety and conformity of the imported goods to the relevant Indian standards.

We kindly request your assistance in facilitating the sampling process across all the ports and ICDs, ensuring that the correct quantities and types of goods are selected for testing. We trust that the BIS laboratory will carry out the necessary tests and provide the required certification for these imported goods.

# We would like to inform you that, upon checking the addresses provided above, you will find the physical stock available at the location at present.

Please do not hesitate to contact us should you need further information or clarification regarding this request. We look forward to your prompt action and the successful completion of the required testing process, it will be beneficial for the Indian textile industry.
