Dear Sir,

Refer communication from Bureau of Indian Standards to know about action initiated by us against Counterfeit /Duplicate /Spurious Legrand RCCB sold by Raj Electrical Chickpet Circle ,BVK Iyengar Road ,Bangalore-560053 .

Raj Electrical is retailer in Bangalore and is not our authorized Stockiest

We have filed a civil suit before Delhi High Court to restrain Raj Electrical, Bangalore, among others, from infringing our IP. The Ld. Court has restrained Raj Electrical from selling the counterfeits and allowed us to conduct a civil raid at his shop vide its Order dt 28.10.2024. The raid was conducted on 11.11.2024, however, no counterfeits were found during the raid.

The injunction order of the Ld. Court is still valid and subsisting and in case Raj Electrical is found to be dealing with our counterfeits again, he will be prosecuted for contempt of court, in addition to other charges.
