Ltd and his son that Boric Acid manufactured by them doesnot conform IS 10116:2015, duly recorded in the circulated Minutes of the above meetings, it humbly requested that strictest action be taken against the above firm by Cancelling their license and initiating prosecution against them, as prescribed in the BIS Act & Rules.
