Subject: Guidelines for grant of BIS licence for Safety of Toys to Toy Packing Units.

1. This has reference to the above.
2. BIS Branch Offices have received applications/queries for grant of licence from toy packing units. During a Webinar arranged on 8 Jan 2021 with toy industry, the industry had also requested that the activity being carried out by these packing units is in the nature of assembly operations and should therefore be considered under the definition of “manufacturing”.
3. The matter was deliberated upon and it has been decided that toy packing units i.e. those units sourcing toy components/parts from outside and carrying out only the packing activity in-house shall also be considered as manufacturing units. (This is specific to toys only and may not be extrapolated to other products).
4. The applications received from such toy packing units shall be processed for grant of licence, under the following conditions:
 - i) The applicant shall provide the documentary proof to the effect that it is a manufacturing unit.
 - ii) The applicant shall provide documentary proof in support of the source/sources from which it is procuring the components/parts of toys manufactured.
 - iii) The applicant has set up the required in-house testing facilities (As per SIT).
5. All ROs/BOs are requested to ensure compliance of the above guidelines and also disseminate the same among applicants and licensees.
