Recommendations of the Raid team

From the above, it is clear that Mittal Electronics 37 & 38, S.S.I. Industrial Area, G.T. Karnal road, Delhi-110033 was storing domestic electric food mixer without ISI mark, thereby violating QCO S.O.5243(E) dated 10 November 2018 as per Sec. 17 of BIS Act, 2016. It is therefore recommended that suitable legal action may be initiated against the said firm.
