You shall not without the prior written consent of the company, publish any book or brochure or article concerning any matter relating to the Company.

Restrictions after leaving the company: After the termination of your employment with Econurture Consulting India Pvt. Ltd:

- i. For twelve months after such termination, you shall not start your own enterprise or a similar organization or join any such or similar organization, which is in direct competition with the business of Econurture Consulting India Pvt. Ltd
- ii. You shall not directly or indirectly, either on your own or in conjunction or with the aid of any other person anytime after such termination:
