Mr Chandresh Vaghaliya from c was contacted and informed that M/s Somnath Sanitary Mart Sahkari Mandli Ltd had taken order from Jamnagar Municipal corporation and through IndiaMart,they contacted M/s PRAJAPATI TRADE LINKS,223,2Nd floor Plot number 26,Road number 44 ,Vikas Royal Arcade, community centre ,Pitampura Delhi for supplying them ISI marked Malathion .Mr Chandresh Vaghaliya informed that as soon as they realised that the Malathion supplied has fake BIS number ,he wrote a letter to Jamnagar Municipal corporation for not using the product. Simultaneaoulsy he also contacted M/s Prajapati Trade Links for taking back the supplied product .Mr Chandresh provided the photograph of the markings on the product Malathion dust.On the packaging ISI mark was there along with IS 11951 and CM/L 8299501 which is expired license of M/s ECKO ELECTRICALS laxmi nagar Delhi for pumpset. He also provided Invoice of the product supplied to Jamnagar Municipal corporation as per which M/s PRAJAPATI TRADE LINKS had issued the invoice to M/s Somnath Sanitary Mart Sahkari Mandali Limited ,whereas the shipment was directly sent to Jamnagar Municipal Corporation .As per Bill the the material was loaded from KOSI (Mathura) via Truck no. HR47D1186.

As per the investigation it has been concluded that :


- 1) Firm M/s PRAJAPATI TRADE LINKS,223,2Nd floor Plot number 26,Road number 44,Vikas Royal Arcade, community centre ,Pitampura Delhi,has supplied the malathion and might had sourced it from some factory in KOSI (Mathura).
- M/s Somnath Sanitary Mart Sahkari Mandli Ltd, Vearval Somnath is a cooperative and has no manufacturing facilities, it had bought the malathion from Delhi firm and product was sent directly to Jamnagar Municipal corporation.
- 3) An investigation may be carried out at M/s PRAJAPATI TRADE LINKS,223,2Nd floor Plot number 26,Road number 44 ,Vikas Royal Arcade, community centre ,Pitampura Delhi, for detailed information of source/manufacturing facilities.

Complaint may be forwarded to DLBO (in whose jurisdiction, Pitampura falls) for further investigation.
