# RESOLUTION OF THE TWENTY-FOURTH MEETING OF THE CONCRETE REINFORCEMENT SECTIONAL COMMITTEE HELD ON 02 JANUARY 2024

#### Item 3 PROGRAMME OF WORK

The Committee noted the position of work as given in the Committee's Programme of Work, and decided to request the Conveners of the concerned Working Groups to send the drafts for revision of IS 1786 and IS 13620 within a fortnight. The Committee also put on record its appreciation for the timely publication of standards for FRP bars (IS 18255:2023, IS 18256:2023) and couplers (IS 16172:2023). The committee also decided to archive IS 10790 (Part 1):1984 and IS 10790 (Part 2):1984 considering that these standards are not referred in any of the standards for reinforcing and prestressing steel and are very old. It was decided to request the concerned working group to review these standards after the completion of work of IS 1786.

#### Item 4 R&D PROJECTS TO BE TAKEN UP BY THE COMMITTEE

The Committee approved the following R&D subjects and their Terms of References (ToRs) with the modification in the duration of the project which was decided to be changed from 3 months to 5 months. It was opined that a realistic time frame should be provided for a result-oriented project.

- a) Study for framing the requirements for quality and performance of High tensile steel bars for prestressing applications;
- b) Study for framing the requirements for quality and performance of Steel wires for prestressing applications;
- c) Study for framing the requirements for quality and performance of Textile reinforcement;
- d) Study for framing the requirements for quality and performance of High yield strength deformed steel bars for concrete reinforcement having strength grades above Fe 600 (ToR to be prepared as per the ToRs discussed and approved during the meeting); and
- e) Study for framing the requirements for quality and performance of Hot-dip zinc coated reinforcing bars for concrete reinforcement (ToR to be prepared as per the ToRs discussed and approved during the meeting).

The following R&D subjects were also agreed, and the responsibility of preparation of their ToRs was given to the expert members identified against them in the table below:
