Subject: Guidelines for implementation of Revised IS 12817:2020 'Stainless Steel Butt Hinges'

- 1. IS 12817:2013 has been revised as IS 12817: 2020 and has been published. The last date for implementation of the revised Standard is **13 June 2021** after which the old Standard shall stand withdrawn.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. The significant changes in the revised Standard as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

6.2	Tables on dimensions and tolerances for medium weight, medium weight (narrow), unequal flap heavy weight, and heavy weight hinges have been updated.

8	Considering varied finishes being now used, the provision for use of other finishes as per the agreement between manufacture and purchaser, has been included
11.2	Additional marking requirements on packing have been incorporated.
10.1	Marking clause has been revised
9	Provisions on sampling have been updated

- 4. Consequent upon the issuance of the revised Standard, existing SIT in the Product Manual has been revised and included in the revised Product Manual Doc: PM/IS 12817/ 2/Jan 2021.
- 5. The guidelines for implementation of the revised Standard is given below:

A. <u>LICENSEES</u>:

(i) All Licensees shall implement the revised Standard by 13 June 2021. BOs shall ensure that no Licences are under operation as per the old Standard after 13 June 2021 The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.

- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports or Test Certificates, as applicable. Verification of implementation of the revised Standard, wherever required, may be done during the next visit, which may normally be completed within three months of the last date of concurrent running.
- (iii) If the Licensee fails to complete all actions by **13 June 2021**, it shall be dealt with as per the prevailing guidelines.

B. <u>APPLICATIONS FOR GRANT OF LICENCE</u>:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto 13 June 2021 and for such cases, Applicant shall give a declaration that they will implement the revised Standard by 13 June 2021.
- (iii) Beyond 13 June 2021 no Licence shall be granted as per the old Standard.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto **13 June 2021** whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
