As per amendment 1, Bond requirement can set as per Solid and cellular sole category, because it is hard to achieve 3.5 N/mm value for cellular material in case if material not tear. Recommend to keep bond requirement as below. 1. For Cellular material : Shall not less than 3.0 N/mm and 2.5 N/mm if material tear. for all clauses 7.1.2, 7.1.3, and 7.1.4. (Applicable on bond with Solid material sole also) 2. For Solid material : Shall not less than 3.5 N/mm and 3.0 N/mm if material tear. for all clauses 7.1.2, 7.1.3, and 7.1.4. Time period not mention.
3	Heel Drop	7.1.9	For round off measurement, Please specify.
4	Martindale abrasion	Clause 7.5, Table 6 S.no. ii	In wet condition, mentioned it is not applicable if full in sock used. Concern : Is it applicable for both Wet and Dry case, or only for Wet condition. Please specify.
5	Water absorption & desorption	Clause 7.5, Table 6 S.no. iii	In water absorption mentioned, applicable on non-water permeable in sock, same should be applicable for wet condition. In Water desorption : Applicable for fabric only, should be same for absorption also. Absorption and desorption both have co-relation, So both tests should be clearly specify, incase of applicability, both will require to perform.
6	CF to Perspiration	Clause 7.3, table 4, S. no. iv	Provided test methods are for leather only, Kindly also mention for non-leather material methods e.g. ISO 105 E04.
7	Sole Tear	Clause 7.6, Table 7, S. no. (iv, v, vi, vii)	Please categorized requirement as per cellular and solid material.
8	Chemical requirement	7.12.1	Applicable on skin contact (Touchable part from hand or foot), not with foot contact.
